Notice of General Meeting

Notice is hereby issued that the 2025 General Meeting of the African Parliamentary Network on IFFs and Taxation (APNIFFT) shall be held physically between 8:30 am and 5:00 pm from Monday, 13 October 2025, to Wednesday, 15 October 2025, in Johannesburg, South Africa.

The agenda shall be as follows:

- 1. Engage in discussions on critical tax and IFF-related issues for APNIFFT members.
- 2. Receive reports on the engagements of APNIFFT regional caucuses.
- 3. Consider proposed amendments to the APNIFFT Constitution.
- 4. Elect APNIFFT Steering Council members in accordance with Article 13 of the APNIFFT constitution.
- 5. Appoint a Chair and Vice Chair for the APNIFFT Steering Council in accordance with Article 12.3 of the APNIFFT Constitution.

Notice of APNIFFT Steering Council Elections

Further notice is issued under Article 13 of the APNIFFT constitution as follows:

- 1. That the elections of the members of the APNIFFT steering council shall be conducted on Wednesday 15th October 2025.
- 2. That any member of APNIFFT who is an elected member of an African parliament and who accepts and commits to the APNIFFT constitution is eligible for election as an APNIFFT Steering Council member under the provisions of Article 9.3 of the APNIFFT constitution.
- 3. That pursuant to Article 13.5 of the APNIFFT constitution, a member of APNIFFT who wishes to vie for position of steering council member, shall submit their application to the secretariat at least 15 days before the election day.
- 4. That APNIFFT members who wish to serve on the APNIFFT Steering Council should send their applications on this link by 30 September 2025.
- 5. Regional caucuses shall elect one representative to the steering council on the election day as provided under Article 13.7 of the APNIFFT constitution.
- 6. That upon election of the representatives of regional caucuses, they shall form the APNIFFT steering council for 2025 to 2027.
- 7. That pursuant to Article 12.3 of the APNIFFT constitution, the members of the APNIFFT Steering council 2025 2027 shall appoint from among themselves a chairperson and vice chairperson on the same date Wednesday 15th October 2025.
